- 1. Call to Order Katie Carner called the meeting to order at 7:00 PM.
- 2. **Committee Procedures and Guidelines** The Cell Tower Exploratory Committee is to evaluate the problem of cell phone reception within the Firethorne community and evaluate what, if any, actions the committee can recommend to the board to solve the problem.
- **3. Confidentiality Agreement** All members present in person sign the Confidentiality Agreement to protect sensitive resident information while serving on the committee. Member present via Zoom are asked to return the emailed copy from Margaret to the HOA office.

- Katie answers questions regarding rules for voting on the final committee recommendation, including submitting request to the board to ask for 2/3 majority vote, etc. and summarizes previous efforts made toward increased cell reception including the Area Review by T-Mobile and an appraisal of real property of MUD land offered as a potential cell tower site.
- Amy Poole volunteers to share committee updates through Social Media.
- Stephanie LaFleur volunteers to take meeting minutes.
- Committee agrees to meet monthly unless otherwise agreed upon or necessary for committee business.
- Bob suggests using apps to record and map out cell strength throughout the neighborhood at different times of day to establish baseline data.
- Committee suggests acquiring heat maps of the neighborhood from other major carriers and locations of future cell sites nearby to compare with T-mobile data and use all collected data to compare once proposed locations are live to see to what extent cell coverage in Firethorne may have improved.

- Committee agrees to create a google drive to store and share all collected information pertinent to the committee, including information from carriers, relevant county or city ordinances, plats, health data, etc.
- The next meeting will be held on Oct. 17, 2023
