Firethorne Community Association, Inc. Trash Can, Recycling Can, and Yard Debris Guidelines

WHEREAS, the Declaration of Covenants, Conditions and Restrictions for Firethorne, a Texas nonprofit corporation, is filed with the Real Property Records of Fort Bend County, Texas, under Clerk's File No. 2005032616, along with any supplements or amendments thereto (collectively referred to as the "Declaration"); and

WHEREAS, Article VII, Section 10 of the Declaration provides that no trash, rubbish, garbage, manure, debris, or offensive material of any kind shall be kept or allowed to remain on any Lot, and that all such matter must be placed in sanitary refuse containers with tight-fitting covers or lids and screened from public view; and

WHEREAS, Article VII, Section 12 of the Declaration provides that garbage cans and other similar items must be located or screened so as to be concealed from view of neighboring streets and property; and

WHEREAS, Article X, Section 8 of the Declaration gives the Board the authority to create rules and regulations which are binding on each Owner and Occupant of Lots within the Properties; and

WHEREAS, Article X, Section 8 also provides that the Board may impose fines for violations of the Declaration and any rules and regulations, which shall be collected as provided in the Declaration for the collection of assessments;

NOW THEREFORE, as evidenced by the certification of enactment below, the following Rules regulating trash cans, recycling cans, and yard debris are hereby established, adopted and imposed on all of the property within the Properties, as follows:

- 1. Placement of Containers: No trash cans, recycling cans, other refuse containers, yard bags, or bundled yard debris shall be placed at the curb for collection prior to 6:00 p.m. the evening before the regularly scheduled collection day.
- 2. Removal of Containers: All trash cans, recycling cans, other refuse containers, yard bags, and bundled yard debris must be removed from the curb and properly stored out of public view no later than 11:59 p.m. on collection day.
- 3. Storage of Containers and Debris: At all times other than the permitted placement windows in these guidelines, all trash cans, recycling cans, other refuse containers, yard bags, and bundled yard debris must be stored so as to be concealed from view of neighboring streets and properties, consistent with the Declaration.
