

CORPORATE RESOLUTION REGARDING NEIGHBORHOOD STATUS FOR FIRETHORNE WEST, SECTION 16

At a special meeting of the Board of Directors of the Firethorne Community Association, Inc. (the "Association"), held on \(\frac{\text{Normal}}{\text{Normal}} \frac{\text{Normal}}{\text{O}} \), 2022, said meeting being properly called and a quorum being present, came to be considered the matter of Neighborhood status for Firethorne West, Section 16.

The legal authority for this action by the Board is found in the Declaration of Covenants, Conditions and Restrictions for Firethorne (the "Declaration"), recorded on March 23, 2005, in the Official Public Records, Fort Bend County, Texas under County Clerk's File No. 2005032616. The properties subject to the Declaration include all real property that has been or may be subsequently annexed to be brought within the jurisdiction of the Association in accordance with the provisions of the Declaration.

Pursuant to the Declaration of Annexation Firethorne West, Section Sixteen (16) dated December 2, 2019, recorded under County Clerk's File No. 2019137209, in the official real property records of Fort Bend County, Texas on December 2, 2019, the property within Firethorne West, Section 16 ("Section 16W" or the "Subdivision") was made subject to the Declaration.

After consideration of the matter, the Board voted to approve the following resolution related to such Neighborhood status, as follows:

WHEREAS, Article I of the Declaration provides the following definitions:

Section 22. "Neighborhood" shall mean and refer to a separately designated and denominated area within the Properties....

Section 23. "Neighborhood Assessments" shall mean assessments levied by the Board of Directors for payment of the Neighborhood Expenses of a particular Neighborhood.

Section 24. "Neighborhood Expenses" shall mean and include the actual and estimated expenses incurred by the Association for the benefit of the Owners and Occupants of the Lots within a particular Neighborhood or Neighborhoods.

WHEREAS, Article II, Section 4 of the Declaration provides a procedure by which Neighborhood status can by created by either the Declarant or if "a platted subdivision has not been designated by the Declarant as a Neighborhood, the Owners of a majority of the Lots in such platted subdivision may petition the Board of Directors for Neighborhood status;" and

WHEREAS, the Declarant did not designate Section 16W as a Neighborhood under the Declaration; and

WHEREAS, the Owners of a majority of the Lots in Section 16W have petitioned the Board of Directors for Neighborhood status, such petition being attached as Exhibit "A" to this Resolution; and

WHEREAS, the Board finds that the Petition complies with the terms of the Declaration, as described above.

NOW, THEREFORE, the Board adopts the following:

ARTICLE I DEFINITIONS

Any capitalized terms which are used in this document and not defined herein shall have the meanings ascribed to them in the Declaration.

ARTICLE II DESIGNATION OF NEIGHBORHOOD

- 1. Neighborhood. Section 4 of the Article II of the Declaration gives the Board the right to designate as portion of the Properties as a Neighborhood. The Subdivision is hereby designated by the Board as the "Firethorne West, Section 16 Neighborhood".
- 2. Neighborhood Assessment. The Owners of Lots within the Firethorne West, Section 16 Neighborhood shall be assessed and are liable to pay a Neighborhood Assessment to the Association in addition to Residential Assessments when levied by the Board from time to time in accordance with Section 2(b) of Article III of the Declaration. It is anticipated that the initial Neighborhood Assessment for the Firethorne West, Section 16 Neighborhood will be \$200.00 per Lot per year.

ARTICLE III PRIVATE STREETS

1. Disclosure. As set forth on the plat of the Subdivision (the "Plat"), all of the Streets within the Subdivision are private Streets. The Streets within the Subdivision have not been dedicated to the public and no governmental entity (including, but not limited to, the City of Houston, Texas, or the County of Fort Bend, Texas) shall be responsible for the repair, maintenance, or upkeep of the Streets within the Subdivision and the gated entry. Any and all matters related to the private Streets within the Subdivision shall be governed by and in keeping with any and all rules and/or regulations now or hereafter enacted by any governmental authority having jurisdiction. Although the Association shall be responsible for the maintenance, repair, and replacement of the Streets within the Subdivision, as more particularly set forth in the

Declaration and this Supplemental Declaration, each and every Owner of a Lot within the Subdivision shall be responsible for paying when due to the Association the Neighborhood Assessment levied on each Lot by the Board of Directors of the Association to provide funds for the maintenance, repair, and replacement of Streets within the Subdivision. Accordingly, whether or not specifically addressed in the conveyance instrument for any Lot within the Subdivision, each Owner of any Single Family Residence or Lot located within the Subdivision shall, by acceptance of delivery of the deed, assume all responsibility for payment to the Association, when due, of the Neighborhood Assessment.

- 2. Reserve Fund. The Association's Board of Directors shall create a reserve fund restricted to use for (i) the maintenance and repair of the private Streets within the Firethorne West, Section 16 Neighborhood and the limited access gates and related improvements and (ii) the reconstruction and replacement of the private Streets within the Firethorne West, Section 16 Neighborhood.
- Markings or Postings. The Association shall, as an expense paid with Neighborhood Assessments, perpetually maintain the markings or posting required for fire lanes, signs giving notice of private Streets, and access control mechanisms for emergency vehicles.

FURTHER, the Board accepts and approves the Petition and designates Section 16W as a Neighborhood for all purposes under the Declaration.

PETITION FOR NEIGHBORHOOD STATUS FOR FIRETHORNE WEST, SECTION SIXTEEN (16)

This Petition for Neighborhood Status (the "Petition") for FIRETHORNE WEST, SECTION SIXTEEN is made as of the date hereinafter set forth by the owners of a majority of the lots in said subdivision (the "Majority Owners").

WITNESSETH:

WHEREAS, JDC/FIRETHORNE, LTD. (the "Declarant") executed that certain Declaration of Covenants, Conditions and Restrictions for Firethorne dated as of March 7, 2005 which is filed under Clerk's File No. 2005032616 and recorded in the Official Records of Fort Bend County, Texas (as amended, the "Declaration"), which imposed covenants, conditions and restrictions on certain property described therein; and

WHEREAS, as contemplated by the Declaration, and pursuant to the applicable provisions thereof, a Texas non-profit corporation has been formed named the Firethorne Community Association, Inc. (hereinafter referred to as the "Association"), the purposes of which are to collect, administer and disburse the maintenance assessments described in the Declaration and to provide for the maintenance, preservation and architectural control of the land encumbered by the Declaration and any additional land which may be subsequently brought within the jurisdiction of the Association; and

WHEREAS, the Majority Owners are the owners of a majority of the 16.95 acre tract of land which has been subdivided and platted as Firethorne West, Section Sixteen (16), a subdivision according to the plat thereof recorded as Plat No. 20190186 in the Plat Records of Fort Bend County, Texas (hereinafter referred to as the "Subdivision"); and

WHEREAS, by that certain Declaration of Annexation executed by Declarant, dated December 1, 2019 and filed under Clerk's File No. 2019137209 in the Official Records of Fort Bend County, Texas, the Subdivision was annexed into the jurisdiction of the Association and made subject to the Declaration; and

WHEREAS, as contemplated by the Declaration and in accordance with the provisions thereof, the Majority Owners wish to petition the Board of Directors of the Association, pursuant to Article II, Section 4, thereof, to give the Subdivision Neighborhood status.

NOW, THEREFORE, for and in consideration of the premises and in furtherance of the general plan of development for the property subject to the Declaration, the Majority Owners hereby petition the Board of Directors of the Association, pursuant to Article II, Section 4, thereof, to give the Subdivision Neighborhood status, to wit:

ARTICLE I DEFINITIONS

Any capitalized terms which are used in this Petition and not defined herein shall have the meanings ascribed to them in the Declaration.

ARTICLE II DESIGNATION OF NEIGHBORHOOD

- 1. Neighborhood. Section 4 of the Article II of the Declaration gives the Board of Directors the authority to designate a portion of the Properties as a Neighborhood when petitioned by the Majority Owners. When the Petition is approved by the Board of Directors, the Subdivision will be designated as the "Firethorne West Section 16 Neighborhood".
- 2. Neighborhood Assessment. When Neighborhood status is granted, the Owners of Lots within the Firethorne West Section 16 Neighborhood shall be assessed and are liable to pay a Neighborhood Assessment to the Association in addition to Residential Assessments when levied by the Association's Board of Directors from time to time in accordance with Section 2(b) of Article III of the Declaration. It is anticipated that the initial Neighborhood Assessment for the Firethorne West Section 16 Neighborhood will be \$200.00 per Lot per year.

ARTICLE III PRIVATE STREETS, ACCESS GATE, NEIGHBORHOOD FENCE AND OTHER AMENITIES

Disclosure. As set forth on the plat of the Subdivision (the "Plat"), all of the Streets within the Subdivision are private Streets. The Streets within the Subdivision have not been dedicated to the public and no governmental entity (including, but not limited to, the City of Houston, Texas, or the County of Fort Bend, Texas) shall be responsible for the repair, maintenance, or upkeep of the Streets within the Subdivision and the gated entry. Any and all matters related to the private Streets within the Subdivision shall be governed by and in keeping with any and all rules and/or regulations now or hereafter enacted by any governmental authority having jurisdiction. Although the Association shall be responsible for the maintenance, repair, and replacement of the Streets within the Subdivision, as more particularly set forth in the Declaration and this Petition, each and every Owner of a Lot within the Subdivision shall be responsible for paying when due to the Association the Neighborhood Assessment levied on each Lot by the Board of Directors of the Association to provide funds for the maintenance, repair, and replacement of Streets within the Subdivision. In addition, the Neighborhood Assessment includes such expenses for the access gate, neighborhood fence and other amenities specific to the Subdivision. Accordingly, whether or not specifically addressed in the conveyance instrument for any Lot within the Subdivision, each Owner of any Single Family Residence or Lot located within the Subdivision shall assume all responsibility for payment to the Association, when due, of the Neighborhood Assessment.

- 2. Reserve Fund. The Association's Board of Directors shall create a reserve fund restricted to use for (i) the maintenance and repair of the private Streets within the Firethorne West Section 16 Neighborhood and the limited access gates and related improvements and (ii) the reconstruction and replacement of the private Streets within the Firethorne West Section 16 Neighborhood.
- 3. Markings or Postings. The Association shall, as an expense paid with Neighborhood Assessments, perpetually maintain the markings or posting required for fire lanes, signs giving notice of private Streets, and access control mechanisms for emergency vehicles.
