- 3. Approve minutes from 9/6/2023
  - a. Blake raised the motion to approve the minutes, Jamie seconded and the motion passed
- 4. Old Business
  - a. Adding New members
    - i. We discussed how the process went. Kristen seemed to think it worked OK. She said the form was straightforward. Noah discussed having those not chosen as non-voting members that could help the work groups. No decision to change was made.
  - b. Field lights update
    - i. Blake stayed with the process from beginning to end for about 10 months.

    - iv. The fencing around the electrical and timer needs to be repaired
